Head quarter, Chief Election commissioner, Sh. V.P. Sanjiv, has issued the directions that elections in all branches have to be completed by 31st May 2019.

The Annual General Body Meeting of Kota branch will be held on 05th May 2019, at Hotel Meenal Residency. After the AGM, the process of elections shall start with nomination, with drawls, casting of vote and counting to be completed thereafter on the same day.

Procedure for the conduct of elections shall be as under:-

1. Election meeting of the Kota Branch will be held on 05th May 2019, at Hotel Meenal Residency, at 7.00 PM.
2. Only the Enlisted contractors would be eligible to contest/vote in the election.
3. Casting of Vote will start at 7.30 PM and continue up to 8.30 PM on 05th May 2019.
4. One candidate can contest for one post only.
5. Only one partner/director/proprietor from one firm can contest for one post only.
6. One person can cast vote only once, even if he/she is partner/director/proprietor in one or more firms.
7. Election process once started shall be completed without any break/recess by the election chairman.
8. All Members, contestants, their proposers and seconders, should have cleared their dues of the Association before participating in the election process.
9. Associates Members do not have voting rights and are not Entitled to contest election nor can propose or second name, of any candidate.
10. Payment of annual subscription and other outstanding dues of the Association will be received by cheque up to 01st May 2019 and in cash up to 5.00 PM on 02nd May 2019, at MESBAI, Kota Branch.
11. Only members, eligible to cast their vote, shall be allowed to enter the election premises.
12. Unauthorized persons/Outsiders will not be allowed to enter the election premises.
13. In case of dispute/issue arising in the course of conducting elections, the decision of Election Chairman, shall be final and binding for the time being. However, it could be challenged in the DRCC and be reviewed by the DRCC after the completion of the election process.
