**ELECTION NOTICE**

**Election of Office Bearers /Council Members/ Executive Body Members for the  
year 2019-21 of Gwalior Branch on 08 May 2019**

Dear Members,

1. Reference Head Quarter letter no. MBAI/Election/02/2019 dt. 01 Apr 2019 and their directions to conduct election in all branches before 31<sup>st</sup> May 2019.
2. In response to above letter our branch Executive Body Meeting was held on 07 Apr 2019 at 1630 Hrs at Hotel Suruchi, and it has been decided to conduct elections of this branch on 08 May 2019 at 1100 Hrs at Hotel Suruchi, Gola Ka Mandir, Gwalior at 1100 Hrs. and unanimously I have been appointed as Election Chairman for these elections.
3. Election will be held for following posts as per details given below:

1. Chairman	1 Post
2. Sr. Vice Chairman	1 Post
3. Vice Chairmen	2 Posts
4. Hony. Secretary	1 Post
5. Hony. Joint Secretary	2 Posts
6. Hony. Treasurer	1 Post
7. Council members	4 Posts
8. Executive Members	15 Posts
9. PRO	1 Post
4. Procedure for conduct of election shall be as under:
  1. AGM/Election meeting of the Gwalior branch will be held on 08 May 2019 at 1100Hrs at Hotel Suruchi, Gola ka Mandir, Gwalior.
  2. Only the enlisted contractors whose name are being figured in the original valid enlistment documents issued by MES enlisting authorities would be eligible to vote/participate in the election process. Representatives, whose names appear in their enlistment letter will only be eligible to participate in Election.

3. All member to carry valid Enlistment documents and original ID proof issued by any department of Government of India to cast their vote.
4. All members are requested to carry two photographs to make Id to enter the election hall.
5. Ballot Boxes shall be sealed immediately after the polling for counting of votes which shall be done immediately. Result of the election will be declared immediately after completion of counting process.
6. One candidate can contest for one post only.
7. Only one Partner / Director/ Proprietor from one firm can contest for one post only.
8. Election process once started shall be completed without any break/ recess by the Election Chairman.
9. All Members, Contestant, their Proposers and Seconders should have cleared their dues of the association before participating in the election process.
10. Associate Members do not have any voting rights and are not entitled to contest nor can propose or second name, of any candidate.
11. Payments of Annual Subscription and other outstanding dues of association will be received by Hony Treasurer by cheque up to and including 25 Apr 2019 and in cash up to date of election before 11:55 AM before commencement of election process. If payment against cheques are not realized before election date, only cash will have to be deposited by the concerned member up to time limit as given here in before to participate/ vote in election.
12. Unauthorized persons/ .outsiders/ Guests will not be allowed to enter in the election premises.
13. Distribution pamphlets/ posters/ banners within election area is strictly prohibited.
14. In case of any dispute/ issue arising in the course of conducting elections, the decision of Chief Election Commission regarding Election matter shall be final and binding for the time being. However, it could be challenged in the DRRC and will be reviewed by DRRC only after the complete election process is over.
