ELECTION NOTICE

**Election of office Bearers/Council Members/Executive Body, for the Year
2019-21 of Delhi Branch on 22 May 2019(Wednesday).**

1. Election of MES Builders Association of India (Regd) Delhi Branch for the term 2019-21. This is to intimate that in the Executive meeting held on 22/04/19 at The Umrao Hotels & Resorts Pvt. Ltd NH-8, New Delhi-37, Unanimously appoint me as Election Chairman. It has also been decided that in accordance with as per provision of the Memorandum of Articles of Association of MES BUILDERS ASSOCIATION OF INDIA (REGD). In this regard Please refer Para 10 Sub Para (a) to (h) in page 13 to 19 of Memorandum of Articles of Association of MES Builders Association of India (Regd.) amended unto 28 July 2018.
2. All dues should be cleared before 3 days i.e (18 May 2019, Saturday) prior before the date of Election i.e 22 may 2019.
3. Only the enlisted contractors whose names & photo are figured in the original valid enlistment letter issued by MES enlisting authority would be eligible to contest/Vote in the election. Members shall submit a copy of valid enlistment documents duly self attested to the Branch minimum one week before the date of election latest by 15 May 2019. Representatives whose name appear in their enlistment letter, will only be eligible to participate in election. Any member loosing or withdrawl of valid enlistment of MES department permanently he will not eligible to caste his vote/contest the election process.
4. Only one Partner/Director/Proprietor from firm can contest for one post only.
5. Associate Members will not have voting rights and will not be entitled to contest for election nor can propose or seconded the name, of any candidate & will not be allowed to enter the election premises.
6. Only eligible members to caste their vote, shall be allowed to the election premises.
7. Unauthorized person, outsider will not be allowed to enter the election premises.
8. Distribution of pamphlets & displaying of poster only banners, gettogether with in the area of election is strictly prohibited.

9. Security arrangement will be made for systematic free & fair election .
10. Election process once started shall be completed without any break/recess by the Election Chairman.
11. One member can contest for only one post of the Branch.
12. All members, contestant, their proposer and seconder, should have paid their dues of the association before participating in the election process.
13. One member will cast one vote even if HE/SHE is Partner/Director/Proprietor in one or more firms.
14. Newly enrolled member will not be eligible to contest in any election of the branch for a period of two years from their date of enrolment.
15. Any member can hold a post in the Branch for maximum 2 tenures of 2 years each. Thereafter, he will not be eligible to contest for the same post. However there is no such embargo to contest for council members & executive members.
16. Election Voting Date & Time 22/05/2019 (Wednesday) from 08:00 am to 3:00 Pm.
17. In Election matters of the Branch the decision of Election Chairman is final & binding for time being. However it could be challenged in the DRRC and will be reviewed by DRRC only after the complete election process is over.
18. Election Should held for the following posts:-

(viii)	Executive Members	:	25 post
