Hon Secretary informed house various policy letter receive from HQ and also letter regarding election procedures and requirements which are also circulated vide email to all members and also on whatsapp.



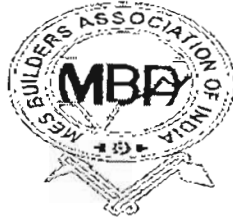

The Election process will start after the end of the Annual general Meeting. Counting of votes will be immediate after election process.


