**ELECTION NOTICE**

**Election of office Bearers/Council Members/Executive Body, for the Year 2019-21 of  
Kolkata Branch on 24<sup>th</sup> May 2019(Friday)**

1. Election of MES Builders Association of India (Regd) Kolkata Branch for the term 2019-21. This is to intimate that in the Executive meeting held on 30.04.2019 at 5/1B, Tara Road, Kolkata-700 026, it was unanimously decided to appoint me as Election Chairman. In this regard please refer Para 10 Sub Para (a) to (h) of page 13 to 19 of Memorandum of Articles of MES Builders Association of India (Regd) amended upto 28 July 2018.
2. All dues should be cleared by Monday, 20<sup>th</sup> May 2019, 3 days prior to the date of Election i.e. 24<sup>th</sup> May 2019.
3. Only the enlisted contractors whose names & photos are figured in the original valid enlistment letter issued by MES enlisting authority, would be eligible to contest/ Vote in the elections. Members shall submit a copy of valid enlistment documents duly self attested to the Branch, one week before the date of election i.e. latest by 15 May 2019. Representatives whose name appears in their enlistment letter, will only be eligible to participate in election. Any member without valid enlistment of MES department shall not be eligible to caste his Vote/Contest the election process.
4. One partner / Director/Proprietor from firm can contest for one post only.
5. Associate Members will not be allowed to enter the election premises since they are not entitled to contest the elections and do not have voting rights.
6. Only eligible members to caste their votes and shall be allowed to the election premises.
7. Unauthorized persons and outsiders will not be allowed to enter the election premises.
8. Distribution of pamphlets , displaying of posters, banners is strictly prohibited.
9. Security arrangement will be made for systematic free & fair election.



10. Election process once started shall be completed without any break/recess by the Election Chairman.

11. One member can contest for one post of the Branch only .

12. All members, contestant, their proposer and seconder, should have paid their dues of the association before participating in the election process.

13. One member will cast only one vote even if HE/SHE is Partner/Director /Proprietor of one or more firms.

14. Newly enrolled member will not be eligible to contest in a elections of the branch for a period of two years from their date of enrolment.

15. Any member can hold a post in the Branch for a maximum of 2 tenures of 2 years each. Moreover, he will not be eligible to contest for the same post. However, there is no such embargo to contest for council members & executive members.

16. Election Voting Date & Time 24.05.2019(Friday) from 3.00pm to 7.00pm

17. In Election matters of the Branch the decision of the Election Chairman is final & binding. However it could be challenged in the DRCC and will be reviewed by DRRC only after the election process is over.

18. Election should held for the following posts:-


