At the outset, I on behalf of all members of the Association and my own express thanks to your honour for accepting our request to reduce GST on Govt. Works Contracts from 18% to 12% vide Notification No.24/2017 dated 21st September 2017.

Sir, vide ibid Notification, GST rate has been reduced on Govt. Works Contracts by making an amendment to earlier notification No.11/2017 dated 28th June 2017. We therefore, request your honour to arrange to issue necessary clarification regarding implementation of revised rate of GST of 12% are applicable w.e.f. 1st July 2017 or from the date of issue of present notification i.e. 21.9.2017, so that our builder members can pay their taxes accordingly.
