**Subject: Collection of subscription for the year 2018-19**

Dear Sir,

Subscription from members for the year 2018-19 falls due on 1<sup>st</sup> April 2018. As per Memorandum and Articles of Association, the subscription has to be collected by the Branches. It is requested that you may send bills to all your members for payment of yearly subscription viz. Rs.2700/- (Subscription Rs. 2500/-, "Contribution for Journal" Rs.100/- and "Contribution for Special Fund at Headquarters" Rs.100/- total Rs.2700/-). As you are aware "Contribution for Journal" is payable by "Life Members" also. Similarly, "Contribution for Special Fund at Headquarters" viz. Rs.100/- is also payable by all Life Members. Bill for Rs.200/- may, therefore, please be sent to them also. Life Members who have paid lump sum of Rs.1500/- on account of contribution for Journal have to pay Rs.100/- on account of "Contribution for Special Fund at Headquarters" only. The entire amount collected on account of "Contribution for Journal" and "Contribution for Special Fund at Headquarters" may be sent to Headquarters along with 50 percent of subscription collected i.e. following amount be sent on account of HQrs share/ dues for various types of members stated below: -

i) Ordinary/ Associate Members	Rs.2700/- each	Rs.1711/-(Rs.1450/-each+ Rs.261/- for GST @18%)
ii) Life Members/ Life Associate Members Who have not paid lump sum contribution For Journal	Rs.200/- each	Rs.236/-(Rs.200/-each+Rs.36/-for GST@18%)
iii) Life Members/ Life Associate Members Who have paid lump sum contribution For Journal	Rs.100/- each	Rs. 118/-(Rs.100/-each + Rs.18 for GST @18%)

As per decision of council Life Members can pay lump sum of Rs.1500/- in lieu of Rs.100/- per annum on account of contribution for Journal and lump sum of Rs.1500/- in lieu of Rs.100/- per annum on account of contribution for special Fund at HQrs, thus, be free from these liabilities for ever. You may like to advise Life Members to do so by paying lump sum amount of Rs.1770/- (Rs. 1500/- +Rs.270/- for GST). **The Members may be requested to pay subscription and other dues at the earliest.**

Since HQ has got registered under GST, therefore you are requested to collect GST on HQ share of subscription / other contribution from members and remit the same. You are also requested to intimate GST number of members to enable us issue invoice in their name.

Kindly ensure that action as above is taken immediately.
